Dear Minister,

As the Population Analyst for BC Stats of the Ministry of Labour and Citizens' Services, I provided many successful solutions to problems with methods and models used to create BC's Official Population Statistics.

Curiously, my refinements including the successful estatsBC project were met with increasing antagonism from the long time employees, including aggressive yelling and racial profiling.

Shortly after filing a grievance wherein I began to disclose to the Deputy Minister, some of the real methods (not published) used by BC Stats, disclosure was abruptly stopped when I was ordered to gather my belongings, turn in my security pass, and leave my office and the BC Stats building.

After a year and a half, an Arbiter agreed with the Ministry to impose a block thereby stopping proceedings; however, the Arbitrator was not aware that a grievance was filed prior to the dismissal.

Could you please reassure the Minister of the right and responsibility of the Minister to evaluate "...the manner in which the legislation (Labour Code) is functioning and to identify problems that may have arisen under its provisions" and to "make recommendations on any specific matter" (BC Labour Code, Section 3 (1), (a) and (c)) including allowing arbitration to proceed.
