Dear Minister,

Thank you very much for having Nancy E. Brown Acting Assistant Deputy Attorney General send me a letter dated May 23, 2012. Thank you for confirming, the Minister of Labour and Citizens' Services and Open Government of the right and responsibility of the Minister to evaluate

"...the manner in which the legislation (Labour Code) is functioning and to identify problems that may have arisen under its provisions" and to "make recommendations on any specific matter" (BC Labour Code, Section 3 (1), (a) and (c)) including allowing arbitration to proceed."

...as per your Ministry's' statement ...

"This is a matter that falls within the responsibilities of the Minister of Labour, Citizens' Services and Open Government, the Honourable Margaret MacDiarmid. I note that you have copied Ms. MacDiarmid on your

email in her capacity as a Member of the Legislative Assembly.”

However, regarding the statement in the letter ...

“I note your concerns regarding your dismissal from BC Stats. It appears that this matter has been dealt with under the collective agreement between the Government of British Columbia and the British Columbia Government and Service Employees’ Union. ”

Please be aware that while “it appears” that this matter was dealt with, I have evidence that proves this matter has not been dealt with.

Regarding the statement ...

“It is not within the mandate of the Minister of Justice and Attorney General to become involved in such disputes.”

Please be aware, cases where BC Government Employees are denied protection under the law because they describe discrimination on grounds covered by the BC Human Rights Code and the Canadian Charter of Rights are within the mandate of the Minister of Justice and Attorney General. I continue to request arbitration, a fair hearing, or public inquiry, to proceed thereby allowing the grievor to face accusers, as well as allowing disclosure of the real methods used by BC Stats to create numbers and allow a neutral board / person to decide whether “just cause” was applicable.
